Thai Marriage Visa

For people who want to get married in Thailand, a 30-day visa is enough to enter the country. After the marriage however, foreigners who want to stay longer with their Thai spouse in the country can apply for a Marriage Visa. This type of visa is valid for a year and can be renewed inside Thailand.

Requirements

- Married to a Thai National
- No criminal history (must be able to enter Thailand)
- A monthly income of at least THB 40,000 or
- Thai bank account of 400,000 baht for 2 months or combination of both

*Holders of this type of visa have to report their current address to the Thai Immigration Police every 90 days.

Thai Business Visa

A Non-Immigrant “B” Visa (Business) visa is required for foreigners who will enter the country to work or set-up a business. Initially, you will be issued a 90-day Non-B Visa by the Thai Embassy in your country, which we will convert to one year after you enter Thailand.

Requirements

There are different requirements for the Business Visa and it depends on the purpose of travel (whether you are here for work, to conduct business, to invest or to teach). Our team of legal experts will assess your case and will provide you the requirement details for that particular purpose.

If you are applying inside Thailand and the purpose is employment, you will need to submit the following records from your company / employer:

- Thai Company sponsorship (2 million baht capital per foreigner)
- Employment of 4 Thai employees per foreigner
- VAT Certificate - Phor Phor 20
- Withholding Tax – Phor Ngor Dor 1
- Social Fund Withholding – Sor Por Sor 1-10

Benefits of the Non-immigrant “B” Visa

Holders of the Non-Immigrant Business Visa are entitled to the following:

- Multiple entries into Thailand (unlimited)
- Valid for use for a period of one calendar year
- Able to stay in Thailand for 90 days each entry
- Ability to obtain work permit for Thailand, if needed
- Able to open bank account in Thailand

Thai Retirement Visa

To start your Thai retirement visa, you need a non-immigrant visa. Ideally, it should be acquired prior to your arrival in Thailand. Siam Legal can assist you in obtaining it in your home country or in a nearby country. In addition, we can help you convert a tourist visa to non-immigrant visa inside Thailand but it can take up to 1 or 2 months for this conversion process.

Requirements

There are special requirements for those who want to apply for the Thai Retirement Visa.

- Applicant must be 50 years of age or older
- No criminal history (must be able to enter Thailand)
- Must have a bank account showing THB 800,000, or monthly income of at least THB 65,000, or a combination of both (bank account + income x 12 = THB 800,000).
